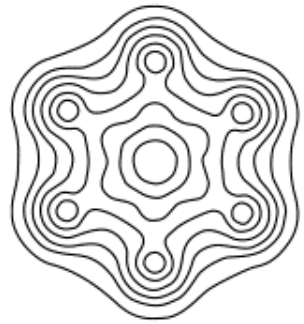
The transport accident information and support system TUIS
